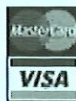

REAL ESTATE TAX:

NO SEPARATE BILL IS MAILED TO YOUR MORTGAGE COMPANY. The property owner is responsible for all taxes. If your bank remits payment for your Real Estate taxes, you must forward this bill to them. (Make a copy for yourself.)

MOTOR VEHICLE TAX:

If a "REGISTRATION APPROVED" stamp is required on your motor vehicle registration, and taxes are past due, payment must be made by cash, cashier's check, money order, or credit card.

A \$25.00 handling fee will be charged for any returned check. Returned checks are not re-deposited and must be repaid in cash.
